TO WHOM IT MAY CONCERN

We do not wish to speak in support of our Submission.

The Taranaki Public Health Unit (Taranaki PHU) welcomes the opportunity to submit on the New Plymouth District Council Long Term Plan 2021 – 2031.

Taranaki PHU is committed to creating a fairer society where everyone has the opportunity for good health, and where our societal systems consider the needs and aspirations of Māori as tangata whenua and work in partnership with Māori through the application of Te Tiriti o Waitangi articles and principles.

Taranaki PHU is one of 12 public health units providing public health services across Aotearoa/New Zealand. We provide a range of services with a focus on promoting health equity and protecting communities against public health hazards, including through a Wellbeing in All Policies approach (WiAP). One of the roles of the Medical Officer of Health is to advise Territorial Authorities and Regional Councils on issues that may impact on the health of the public.

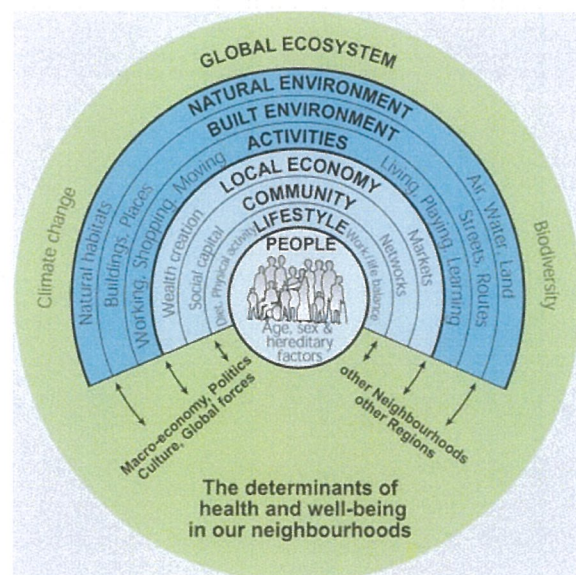


Figure 1 The Determinants of Health and Wellbeing in Communities (Whitehead & Dahlgren, 2006)

WiAP is a cross-sectoral approach to policy that considers the health and wellbeing implications of policy decisions, in order to improve population health and equity. Many of the determinants of health lie beyond the control or influence of the health sector and the individual and form a complex system of factors that determine health outcomes (Figure 1). The decisions of local government play a direct role in the determinants of health in communities.

Please find the following comments for your consideration:

Fixing our Plumbing

How much should we invest in fixing our plumbing over the next 10 years?

Council Preferred is Option 3 – Medium investment reduces risk of critical asset failure to moderate (50%) and clears backlog over 20 years.

How do we pay for fixing our plumbing?

Council Preferred is Option B – partial funding of long-life assets with debt.

Taranaki PHU **supports** the Council's infrastructure strategy for its 'plumbing' systems. It is important to ensure that the development and design of wastewater systems complements future community development but is also focused in areas where there are known issues, like Urenui. The Resource Management Act 1991 requires the Council to sustainably manage the use, development, and protection of natural resources in a way or at a rate, which enables people and communities to provide for their social, economic and cultural well-being and for their health and safety while avoiding, remedying or mitigating any adverse effects of activities on the environment.

Improving stormwater management in Waitara:

We **support the recommended Option 3** to improve the management of stormwater in Waitara throughout the ten-year period of the plan and beyond.

Saving water and water meters:

Council Preferred is Option 3 – Introduction of moderate conservation measures, including water meters.

We **support the council's proposal** to increase community and commercial education programmes around water consumption and conservation.

Taranaki PHU is interested in working with NPDC to undertake a Health Impact Assessment (HIA) of the water meter scheme. We recommend that the Council engages widely across communities to inform the development of the education programmes and implements a range of approaches to ensure messages are received across the population. We note that the council have identified that there may be an increase of cost for water use in some (especially larger) households. We suggest increased promotion of the NPDC Home Energy Scheme being able to be accessed to install rainwater tanks.

Greening our Place

Extending our tracks and trails network:

We **encourage the council to consider Option 3** where the full network of tracks and trails is completed over 10 years.

We support an emphasis on commuter connections in the tracks and trails network allowing people to utilise active transport choices for all or part of their day-to-day journeys to for example work or school. Active commuting has many benefits to health and wellbeing through increased physical

activity and its associated benefits¹², an environment that is supportive of people making active transport choices increases the chance that people are regularly active.³ People who walk or cycle to their main activity are also more likely to meet physical activity guidelines.⁴ Investment in active transport infrastructure increases utilisation of these transport modes⁵⁶. Active commuting can also support efforts to address climate change.⁷ We encourage the council to take a ‘whole of trip’ approach when planning tracks and trails to promote an integrated transport environment. Tracks and trails could also feature art/sculpture and increase sense of place through co-design.

We support infrastructure safety improvements to reduce deaths and serious injuries in our transport system. Taranaki has one of the highest rates of traffic injury hospitalisation (119.1 per 100,000 population), the third highest in 2018.⁸ In the New Plymouth District, the rate of fatal and injury road crashes was 177 per 100,000 people in 2018.⁹ In the Midland region (Bay of Plenty, Lakes, Hauora Tairāwhiti, Taranaki and Waikato), road traffic crashes are over-represented in major trauma statistics and are the second greatest contributor to causes of injury, closely followed by motorcycle crashes and cycle crashes.¹⁰

Boosting our Climate Action Framework:

We **encourage the council to consider Option 3** where the funding of the CAF is for the full 10-year period of the LTP.

Climate change poses a significant threat to public health and adequate funding is needed to investigate and implement strategy to address this. Impact of climate change disproportionately affects those most vulnerable or who are already experiencing disadvantage.¹¹ Privileging active and public transport in decision making has the potential to improve climate change outcomes.¹²

We support the provision of infrastructure and funding that prioritises aligning climate goals with health and wellbeing benefits.¹³ We support investment in projects including increased walking and

cycling, energy efficient healthy homes and buildings and environmental strategy such as planting to increase indigenous biodiversity to address the impacts of climate changes.

Paying it Forward

Building a multi-sport hub:

We support plans to build a multi-sport hub.

The provision of sport and recreation facilities can contribute to health and wellbeing by increasing participation in sport.¹⁴ Benefits include increased physical activity levels as well as the social benefits associated with quality community facilities. A 2019 report from Sport New Zealand identified that non-competitive and informal sport represented a significant proportion of the physical activity undertaken by New Zealanders, and that participation in physical activity declines with age, it also identified that 63% of young people and 75% of adults would like to increase their participation in physical activity.¹⁵ We encourage the council to consider the needs of those who participate in informal sport, as well as the needs of community groups that promote physical activity, as part of ongoing planning for this facility. We recommend that a Multi-Sport Hub provides opportunity for people of all ages and abilities to participate in physical activity.

The consideration of transport modes to and from the multi-sport hub, for the whole population, should be a key part of planning for this project. This could include reviewing bus routes and active transport infrastructure, to ensure it is available and appropriate for the whole community.

Other Comments for Consideration:

Increased cost of entry to Pools:

Drowning is the leading cause of recreational death in New Zealand, the second highest cause of death by unintentional injury in people aged 1-24 and is the third highest cause of accidental death in New Zealand. Education and water skills are considered essential to reduce accidental drownings.¹⁶

Cost should not be a barrier to learning to swim. To increase the availability of opportunities for children and young people to practice this essential life skill, as well as participate in physical activity, **we encourage the council to not increase the cost of child and student admission or supervising adults to council pools. We support the council's decision not to increase entry fees to community services card holders.**

Working with Tangata Whenua:

We support NPDC's plan to provide funding for Iwi/hapū to participate in resource management processes and the councils plan to work in partnership with Tangata Whenua through co-design.

We encourage the Council to ensure that this is communicated widely within Māori networks, so that community are aware of the work the Council is doing in this space. This will also ensure that individuals/groups who may have a stake or knowledge in this space are included and their voices are heard.

Library Upgrades:

If additional funding can be secured alongside the water infrastructure priorities in the infrastructure plan, we recommend the **Council to reconsider delaying the improvements to Waitara and Bell Block libraries and incorporating it into the ten-year time frame of the Long-Term Plan.**

Research indicates that characteristics of neighbourhoods such as the availability of services like libraries have an influence on health outcomes. As Councils play a key role in the social, physical and economic environments of communities, they therefore also have a key role to play in addressing the equity of resource access within the community.¹⁷ Investment in public libraries can provide significant return in community benefits including as a community space, supporting children's educational achievement and increasing social capital.¹⁸ Public libraries can also reduce inequality through access to technology and 'reducing the digital divide'.¹⁹

Housing/Urban Development:

We **recommend that in conjunction with the identification of areas for future housing development that the Council prioritise the development of a regional housing strategy (including affordable homes).** Plans for increased housing development should also include strategy around the provision of active and public transport infrastructure, as well as community facilities, green spaces and access to healthcare, commerce and education.

We also recommend that the Council consider increasing amount of housing for the elderly that is provided by the Council to align with the expected growth in the population of the district aged over 65.

We support the ongoing implementation of the expanded Home Energy Scheme and recommend that this Scheme be continued over the full period of the plan. To encourage homeowners to utilise the scheme Council could consider expanding it to include weathertightness issues and repairs, and home safety improvements.

Waste Management and Minimisation:

We **support education and other strategies to reduce waste going to landfill and promote recycling.** We also **support the Council's plan to provide funding for exposed historic rubbish site remediations.**

Impact on Rates:

We support the continuation of the rates rebate scheme.

We encourage the Council to consider work that is targeted towards neighbourhoods where children may have less access to playground facilities, and/or caregivers who may not have access to private vehicles to travel beyond the confines of their neighbourhood, to ensure equitable access to playgrounds for all children in the New Plymouth District.

Taranaki PHU is available to partner with Council on policy development through undertaking health impact assessments of policy, providing advice regarding the equity outcomes of policy alongside providing background research on the public health impacts/outcomes of policy. Fixing our plumbing

How much should we invest in our plumbing over the next 10 years?

Option 3. Medium. Clear out the backlog and start making some improvements. \$140 million additional funding. NPDC's preferred option.

How do we pay for fixing our plumbing?

Option B: Partially debt fund long life assets to bridge the gap. NPDC's preferred option.

Comments

We appreciate the investment that has been made in the Inglewood infrastructure in the past but we still want to see a priority on alleviating the backlog that is preventing growth and property development.

Saving water and water meters

Option 4: High. A significant water saving plan, including water meters. This will cost \$56 million over 10 years while reducing new water supply assets, saving \$120 million over the long term.

Comments

Of the 466 responses received, 74% wanted to see improvements made to safety and accessibility along this popular walkway. The long-term aspiration is that this walkway becomes a critical part of the walkway network which combines Windsor Walkway to PG Nops, Joe Gibbs and Trimble Park walkways. If this project cannot be completed to a safe level for all users, which includes visitors to Inglewood, then the signage needs to be removed.

Rata Street Pedestrian Crossing The Inglewood Community Board request that the Council pursues all lines of negotiation with NZTA / Waka Kotahi with the aim of resolving the public concerns of no safe pedestrian crossing on Rata St near the Purple Diary. Council Officers have been investigating this for some time and whilst sympathetic, they struggle to get NZTA / Waka Kotahi engaged with this very public safety issue.

Shading for Jubilee Park (PK3024) This park is a destination and well used park for Inglewood. With the establishment of the new mini golf it is anticipated that it will become even more popular. There is currently only one picnic table and no shading available for users. The play equipment becomes too hot for children to use during peak times over summer. The Community board would like to see some shading put in place over the playground and more picnic tables for playground users. It is currently planned year 6 of the LTP, and this is unacceptable to the Inglewood Community Board and we would like to see it brought forward to Year 1. The Moa Project is programmed for Years 1-2 and this is a community funded project that does not require any funding from Council. The Inglewood Community Board would like to see the funds proposed for this project transferred to provide shading in Jubilee Park. The Moa Project is an advocacy project only for the Inglewood Community Board.

Inglewood Pool Shading (AQ3012) The Inglewood Pool Shelter is important for our community. The Inglewood Community Board would like to see the funding proposed for the Elliot St Precinct in Year 6 transferred to the provision of shading over the Inglewood Pool surrounds (concourse of pool).

Motorhome Dump Station (WW2300) The Inglewood Community Board values this project and note that there has been a significant offer from private parties to facilitate this project. The Community Board would like assurance that this project will go ahead in Years 1 or 2 of the LTP 2021-2031.

Yellow Bristle Grass Yellow Bristle Grass is classified as a pest weed by Taranaki Regional Council. It is becoming more prevalent on our country roads. The Inglewood Community Board ask that NPDC ensure that mowing and spraying roadsides does not occur during the period when this pest weed is in seed.
