## 4.1 Background

Any Minister of the Crown or a local authority with financial responsibility for a public work, or a NETWORK UTILITY that has been approved as a requiring authority under section 167 of the ACT may require land to be designated within the District Plan. Under section 176 of the ACT, where a designation is included in the District Plan, the requiring authority responsible for the designation may do anything in accordance with the purpose of the designation.

The majority of designations incorporated in the District Plan have been “carried forward” under clause 4 of the First Schedule of the ACT, in an unmodified form from the previous designations in the Transitional District Plan as provided for in section 184 of the ACT. In addition there are a small number of completely new designations. Designations incorporated into this plan that have not been given effect to will lapse five years from the date the District Plan becomes operative.

Each designation has been allocated a specific code and number, for example C23. The code represents (C) for Ministers of the Crown, (L) for local authority and (N) for NETWORK UTILITY operators. All of the designations are contained within schedules 4.2 to 4.5 and are also shown on the relevant planning maps.
