Under Principles 6 and 7 of the Privacy Act 2020, you have the right of access to, and correction of, any personal information that you have provided.

Collection of official information

All information provided to MPI and NPDC is official information and may be subject to a request made under the Official Information Act 1982. If a request is made under that Act for information you have provided in this application, MPI and NPDC must consider any such request in accordance with its obligations under the Official Information Act 1982 and any other applicable legislation.

Conflict of interest

The Registration Authority/Recognised Agency will mitigate and record any actual, potential or perceived conflict of interest there may be with a food business.
