21.1 Criteria for determining SIGNIFICANT NATURAL AREAS

In determining whether a natural area is a SIGNIFICANT NATURAL AREA, the COUNCIL will consider the following criteria:

- 1 Occurrence of an endemic species that is:
 - Endangered;
 - Vulnerable;
 - Rare;
 - Regionally threatened; or
 - Of limited abundance throughout the country.
- 2 Areas of important habitat for:
 - Nationally vulnerable or rare species; or
 - An internationally uncommon species (breeding and/or migratory).
- 3 Ecosystems or examples of an original habitat type, sequence or mosaic which are:
 - Nationally rare or uncommon;
 - Rare within the ecological region;
 - Uncommon elsewhere in that ecological district or region but contain all or almost all species typical of that habitat type (for that region or district); or
 - Not well represented in protected areas.
- 4 An area where any particular species is exceptional in terms of abundance or habitat.
- 5 Buffering and connectivity is provided to, or by the area.
- 6 Extent of management input required to ensure sustainability.

SNA Name: Mokau-Mohakatino Coastal Cliffs
Site Location: Mokau Road SH3 North Taranaki
Legal Description: Mokau Mohakatino 1B Blk I Tainui SD; PART Mokau Mohakatino 2C1B; Section 1 SO 13221; PT Lot 2 DP 3223; PART Mokau Mohakatino 2C2A; WHOL Mokau Mohakatino 1B
DP Map No: A10
SNA Value: Coastal cliff communities including indigenous coastal herbfield and shrubland interspersed with exotic herbs and shrubs. The site includes areas of dune and a unique coastal wetland on adjacent marine terrace supports a mosaic of *Isolepis prolifer*, *Eleocharis gracilis*, flax and *Cortaderia toetoe*. The only known record in the North Taranaki Ecological District of *Juncus caespiticius*. The site has high species diversity, including indigenous vegetation and coastal birdlife. Approximately 19ha.

SNA Value: A narrow cliff-bound coastal promontory. Vigorously regenerating coastal vegetation is dense and wind shorn. Features occasional emergent rewarewa over a diverse canopy, including occasional kohekohe, karaka, mapou, hangehange, rangiora, mahoe, mamaku, wheki and karamu. Flax, toitoi and oioi fringe the cliff tops. The site is likely to provide habitat for a number of forest and coastal bird species. One of the few remaining natural areas on the uplifted marine terrace. Approximately 2ha.

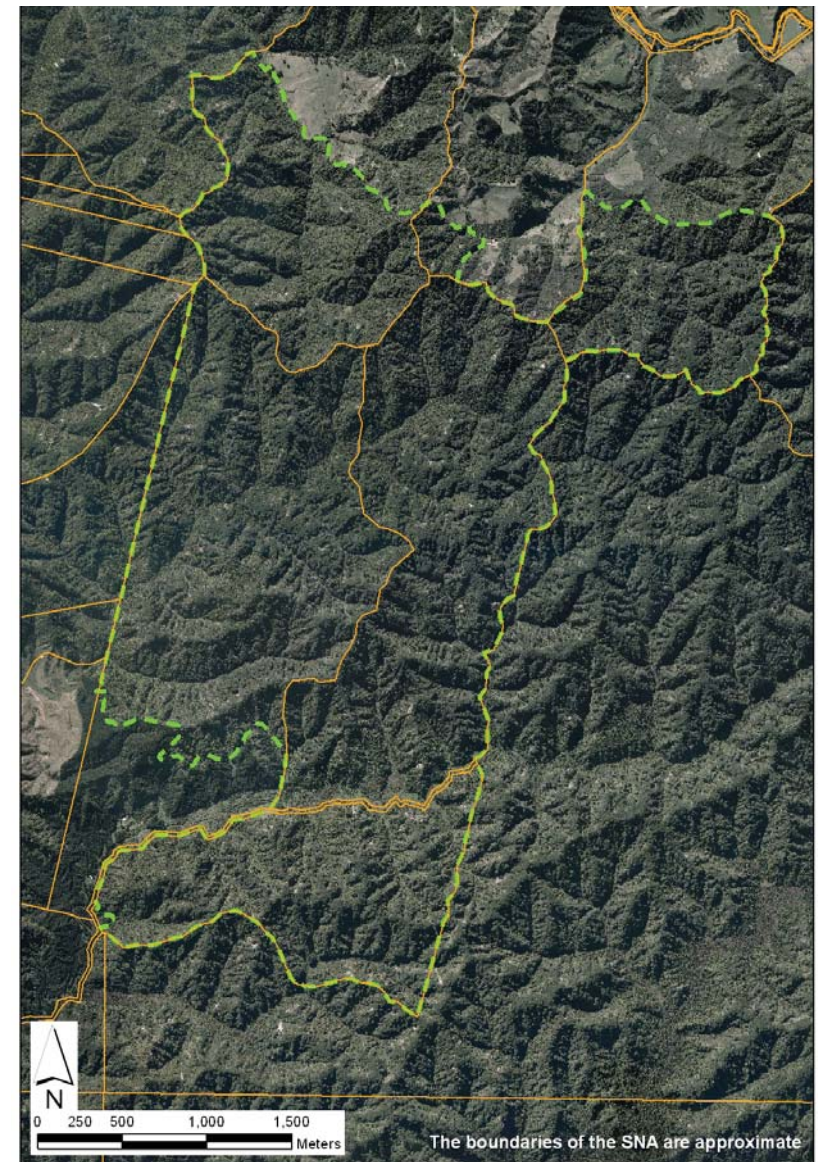

SNA Value: An intact steep and bluffy catchment with a relatively large area of continuous coastal and semi-coastal forest mostly in excellent condition. The wide range of vegetation types includes the only truly coastal hard beech forest in the ecological district and one of the few such stands in the North Island; tawa forest with rewarewa, hinau and rimu on the dry interior ridges and slopes; puriri, karaka, mangao, kohekohe, nikau, ti kouka and frequent kahikatea and pukatea in the gully bottoms; coastal scrub of which akeake is an important component. Notable species include the nationally threatened king fern, and the regionally uncommon whau, mangao, tanekaha, *Adiantum fulvidum*, *Metrosideros carminea* and *Olearia albida*. A wide range of forest birds are present, including the 'nationally vulnerable' bush falcon. North Island kaka and North Island brown kiwi are likely to be present. Approximately 1277ha.

- SNA Value: Semi-coastal and lowland forest between the coastal forests of Kuwhatahi and the lowland forests of Hutiwai, thus providing a continuous gradation of forest types from the coast inland. Vegetation types include hard beech forest, tawa forest, pukatea-kahikatea/wheki-ramarama/*Carex virgata* tussock-treeland, with some areas of regenerating forest including rewarewa, manuka, mamaku, mahoe, pate lancewood and wheki. A wide range of forest birds are present, including the 'nationally vulnerable' bush falcon. North Island kaka and North Island brown kiwi are likely to be present. Approximately 1205ha.

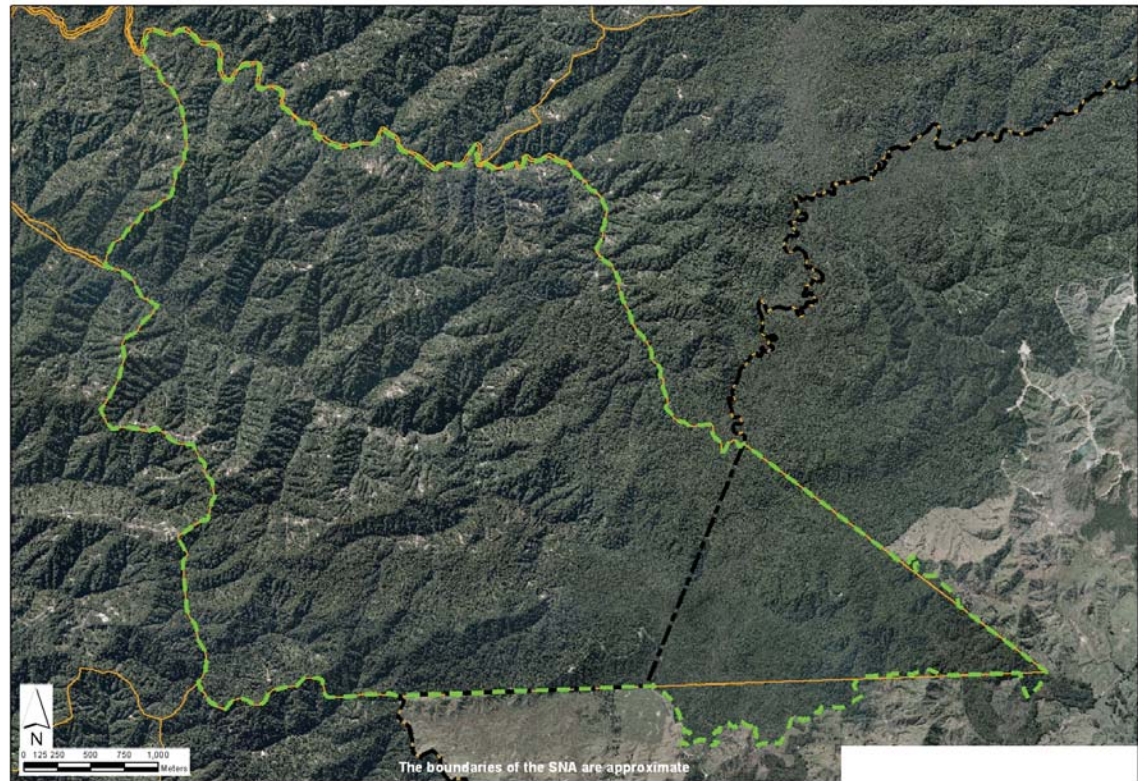

SNA Value: A perched basin similar to Mount Damper, contiguous with other remnants to the coast. Vegetation types include rimu-rich primary forest, tawa-kamahi forest, kamahi-quintinia-toro forest, hard beech forest on gentle terrain (unique) as well as on the ridges and hillslopes, remnants of silver beech forest and an extensive mire of induced kahikatea/manuka-Gahnia xanthocarpa tussock-shrubland. This area of silver beech, a distant outlier from other stands, is the northern limit for the species on the western side of the North Island and appears to be a relic of a former more widespread distribution in Taranaki. A wide range of indigenous forest birds are likely to be present. Approximately 1855ha.

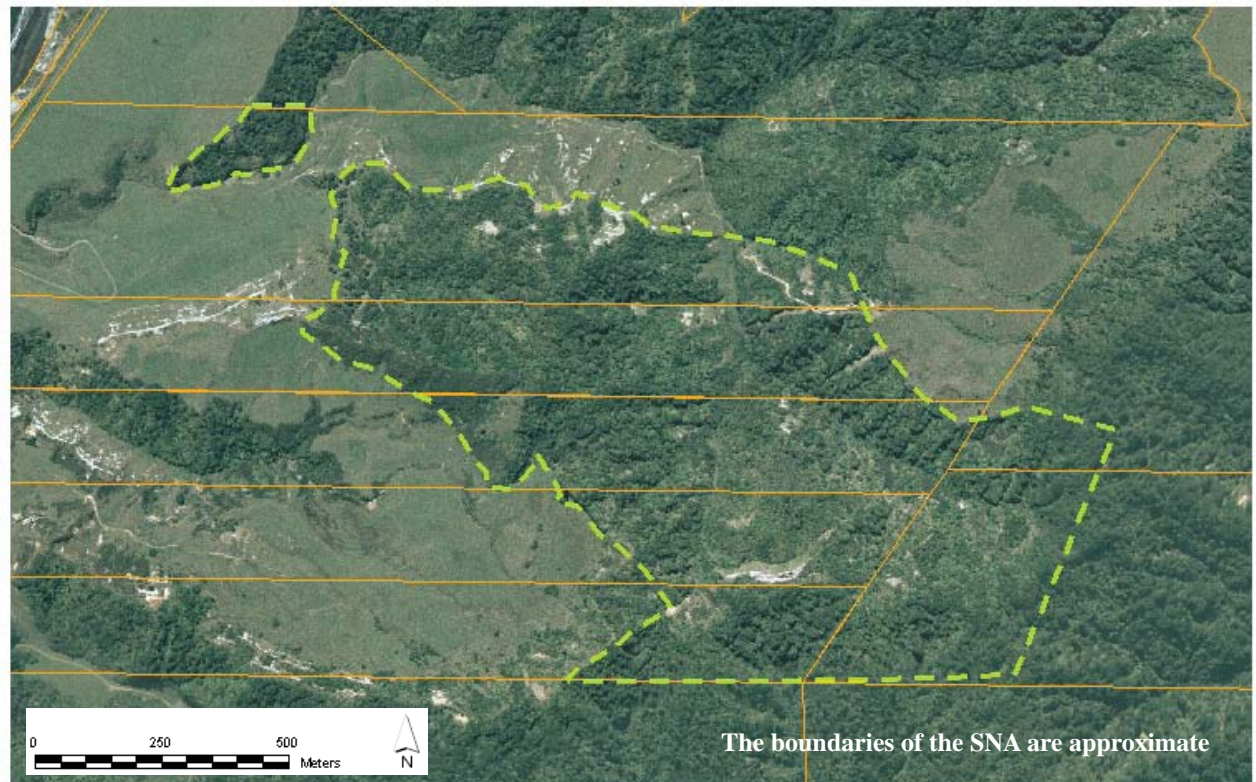

SNA Value: Coastal forest adjoining Whitecliffs stewardship area which includes tawa-puriri-mahoe forest. Enhances the existing protected area to make the best example of primary coastal hardwood and podocarp-hardwood forest on the west coast of the North Island. Approximately 80ha.

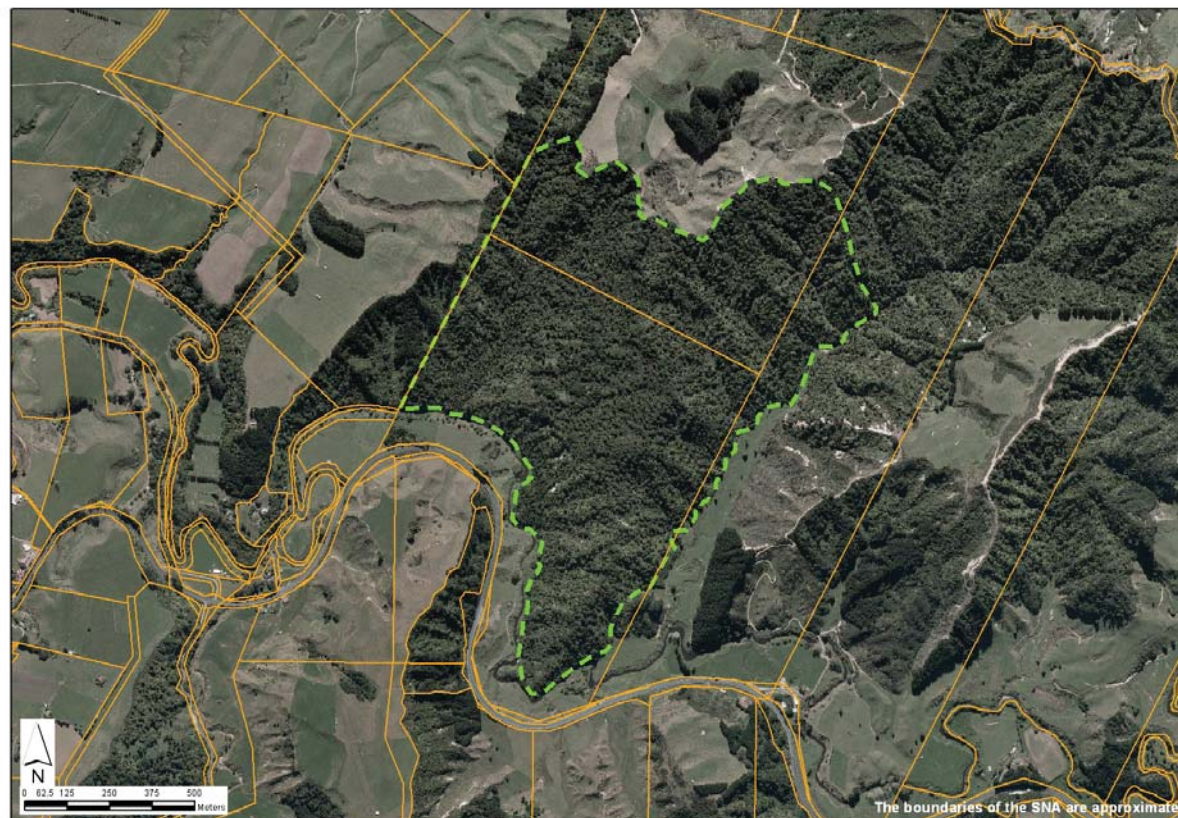

SNA Value: Forested alluvial terrace steep ridges, slopes and cliffs adjacent to the Mimi River. Dominant forest types are tawa-rewarewa and pukatea forest and associated semi-coastal species include kohekohe, kawakawa, nikau and puriri, and manuka scrub. There is a plateau towards the western corner of the site above the river with three small clearings that were grazed in the past and that are now reverting to indigenous species. Also cliff vegetation with kiekie, tutu, koromiko and manuka, and *Brachyglottis turneri*, a lowland species of local distribution. The only known occurrence of *Arthropteris tenella* in the district, a fern of well-drained coastal sites. The forest and riparian vegetation provide habitat for a range of indigenous birdlife. Approximately 109ha.

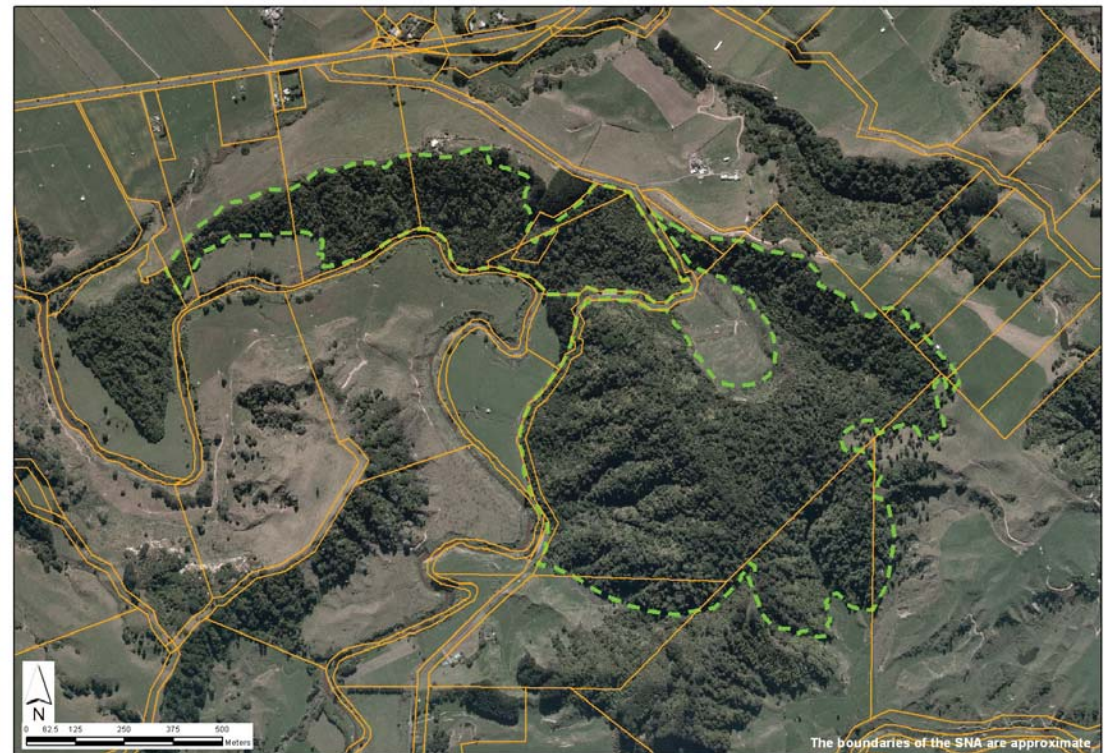

SNA Value: Semi-coastal-lowland forest bisected by Okoki Road. Areas to the west comprise a forested ridgeline dropping steeply to the Urenui River. Areas to the east comprise steep hill country with a distinct cliff bound basin adjacent Okoki Road. The site incorporates a variety of semi-coastal forest types of high naturalness and species diversity, with tawa, puriri pukatea, rewarewa kohekohe, nikau, pate, rangiora and kawakawa being common. Some steeper areas of regenerating scrub include mamaku, manuka, kanuka, pidgeonwood and flax to form natural boundaries. A small tongue of manuka-mamaku scrub links this area with Okoki Pa Scenic and Historic Reserve. The forest and riparian vegetation provide habitat for a range of indigenous birdlife. Approximately 94ha.

SNA Value: Two small estuarine-coastal hillslope strips. The area flanking the Urenui River in the west consists of karaka dominant coastal forest, with scattered mamaku, ti kouka and occasional emergent rewarewa. Flax and *Machaerina sinclairii* overhang the lower bluffs. The area flanking the golf club in the east is comprised of lower stature secondary forest dominated by mahoe, mamaku, kawakawa and hangehange. Notable species include wharangi, *Fuchsia perscandens*, kowhai, *Gahnia lacera*. Remnants of what has been almost completely cleared from the uplifted marine terrace, the forest and riparian vegetation are likely to provide important habitat for a range of indigenous forest and estuarine birdlife. Approximately 3.5ha.

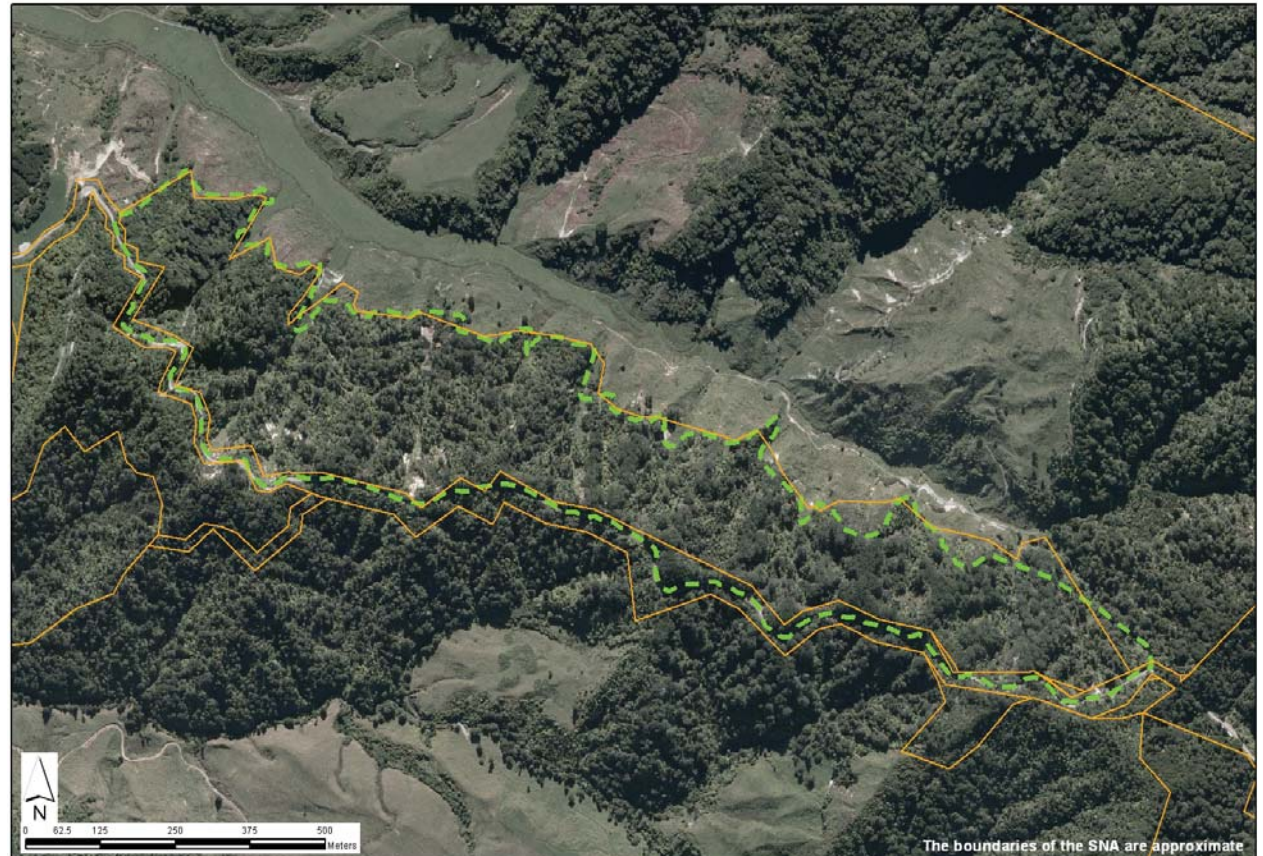

SNA Value: Hillslope includes hard beech-tawa forest and associates not present in adjoining scenic reserves. Also hybrids of black and hard beech, Hall's totara, *Mida salicifolia* (uncommon in the district); *Astelia trinervia* and *Lycopodium deuterodensum* near their North Island southern limits; and *Dracophyllum strictum*-dominant cliff vegetation. Provides habitat for a range of indigenous forest birdlife. Approximately 42ha.

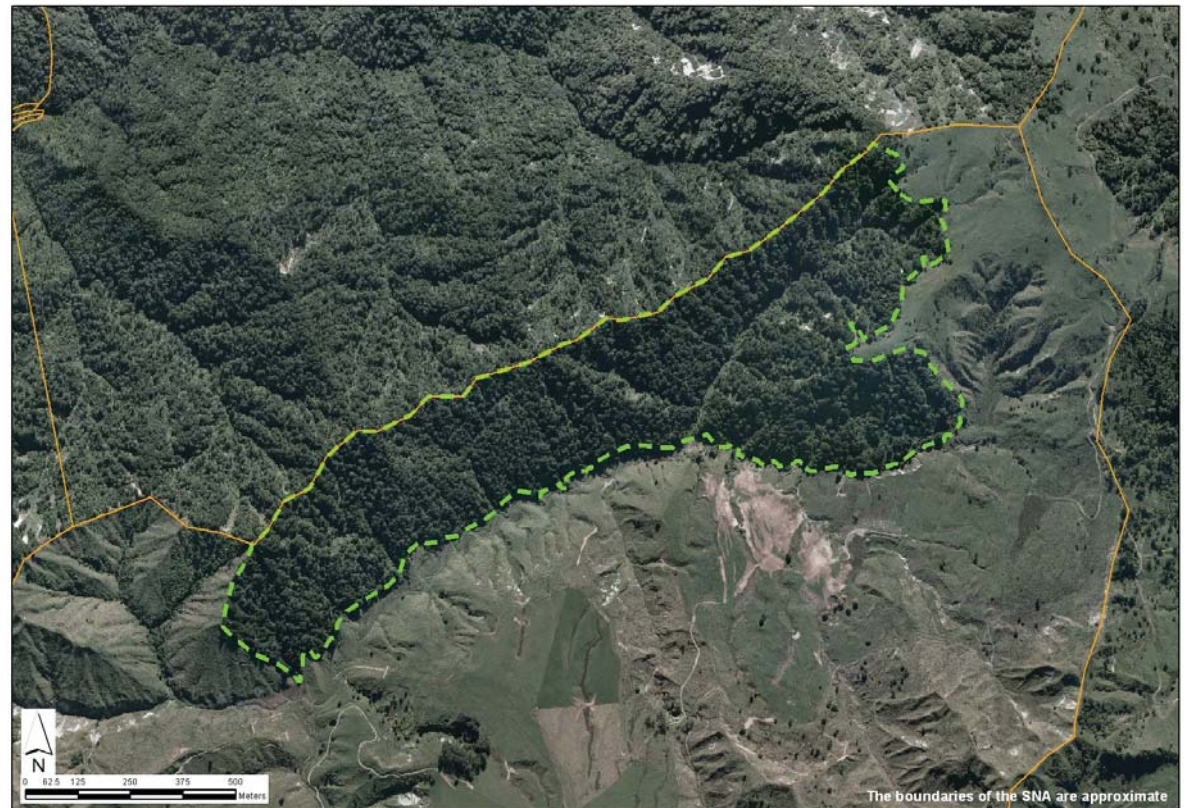

SNA Value: Predominantly tawa forest interspersed with rewarewa, hinau, pukatea, rimu and miro. Includes hard beech forest and associates not present in adjoining scenic reserves. Also hybrids of black and hard beech, *Mida salicifolia* (uncommon in district); *Astelia trinervia* and *Lycopodium deuterodensum* near their North Island southern limits; and *Dracophyllum strictum*-dominant cliff vegetation. Provides habitat for a range of indigenous forest birdlife. Approximately 70ha.

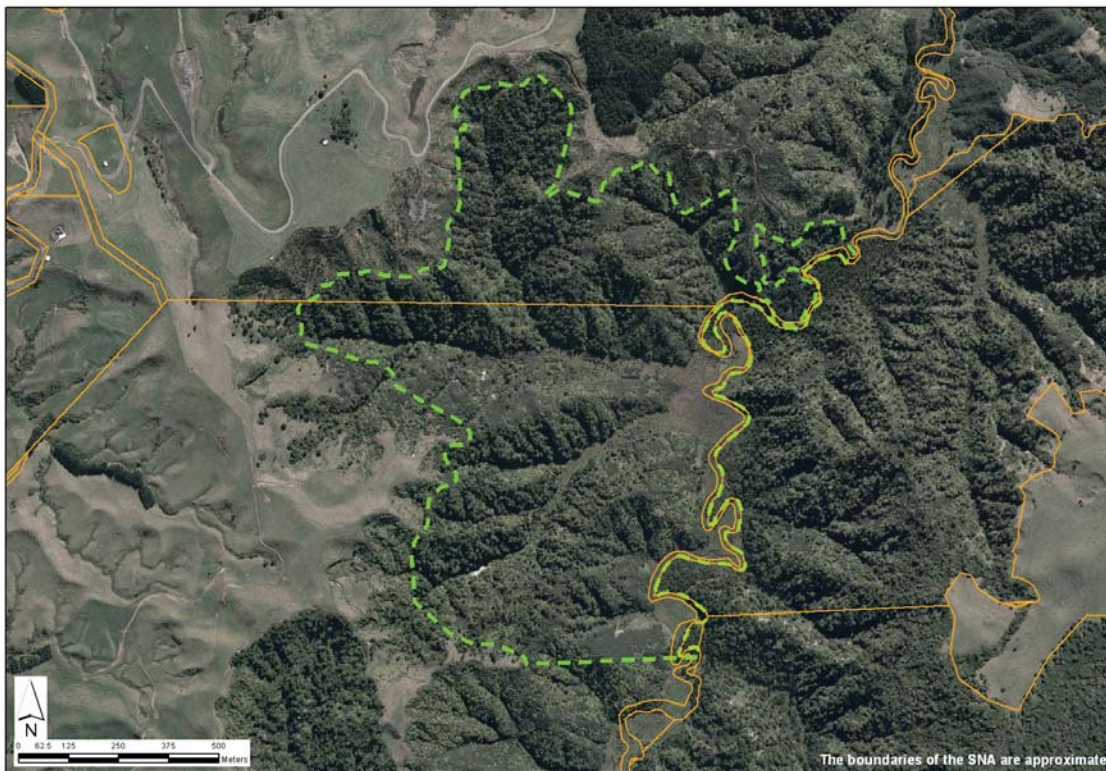

SNA Value: Lowland forest on ridges, hill slopes and alluvial terraces adjacent the Onaero River. Vegetation types on and adjacent the valley floor include; small areas of secondary alluvial forest with kahikatea and pukatea with high naturalness; a small enclave of primary kahikatea forest representing a type now very rare in the district; raupo wetland; carex and rush wetland; and manuka wetland. Vegetation types on the ridge/hillslope areas include tawa-rewarewa-mamaku forest; mamaku-manuka scrub; and also rimu-kohekohe-pukatea forest. Provides habitat for a range of indigenous forest and riverine birdlife, and fern bird ('Declining') has been recorded at the site. The headwaters of the Onaero River provide habitat for a range of indigenous freshwater fish, including banded kokopu. Approximately 138ha.

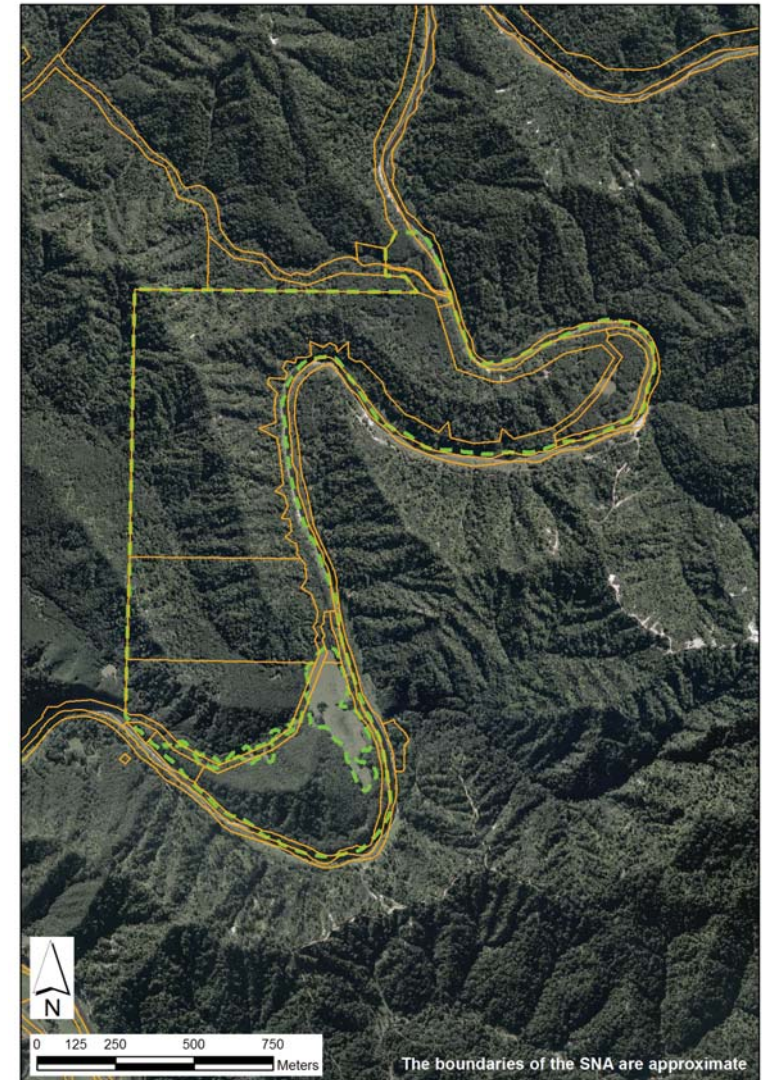

SNA Value: Steep hill country and river terraces draining to the Waitara River. Tawa-rewarewa forest dominates the hill country, with scattered hinau, rimu, miro, matai and pukatea. On the river terraces and lower slopes well advanced stands of kanuka; dominate above lacebark, putaputaweta, ongaonga, kaikomako, ramarama and raukawa. An uncommon forest type in the district and rare on such a large scale. Connects with the Pouiatoa Conservation Area, with the Waitara River forming a natural boundary. A wide range of indigenous birdlife has been observed at the site and adjacent Waitara River, and North Island kaka, brown kiwi and bush falcon have been recorded in the adjacent Pouiatoa Conservation Area. Approximately 139ha.

Houpara (*Pseudopanax lessonii*) (regionally uncommon) is present towards the north of the site. This forest type of the uplifted marine terrace/ring plain is now uncommon. Provides habitat for a range of indigenous forest birdlife. Approximately 2.3ha.

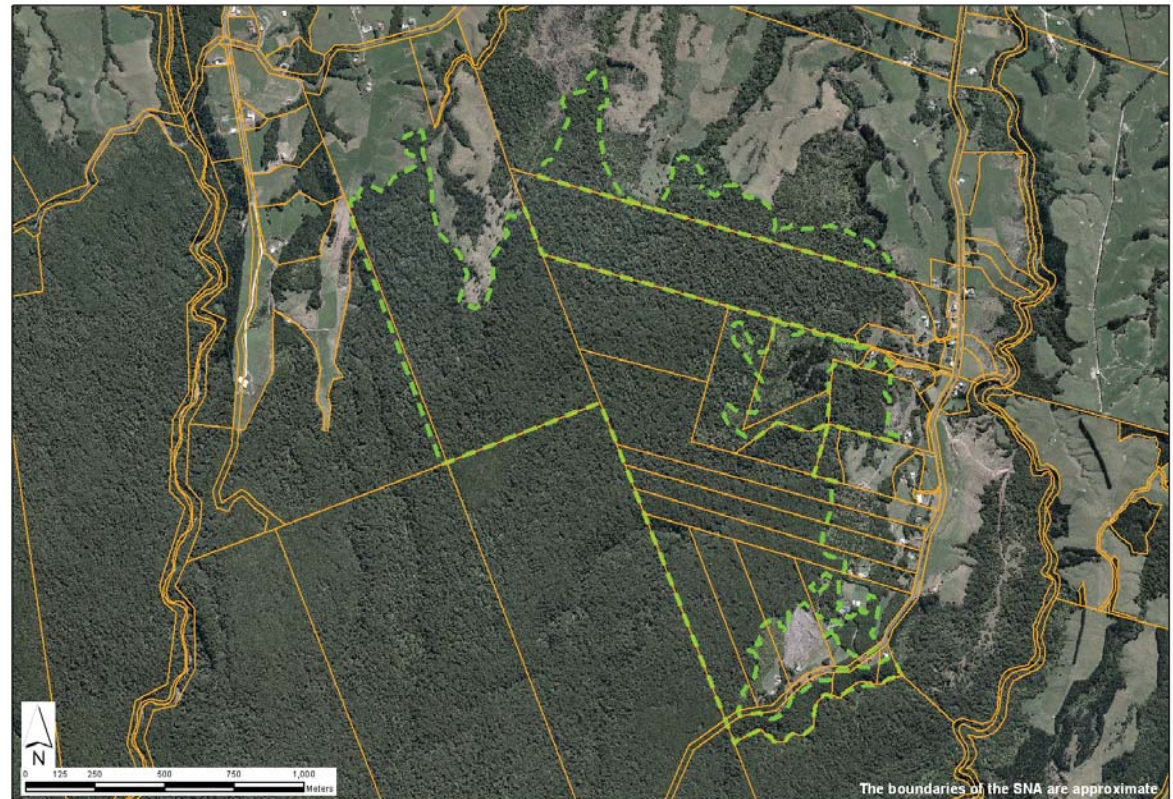

SNA Value: A large remnant on Pouakai Ring Plain which extends the range of forest types from those protected in the adjoining National Park to those of lower altitude. Kamahi forest is most prevalent, with scattered rewarewa and occasional emergent northern rata. Areas of secondary forest are more diverse with kamahi, totara, treeferns, karamu, kanono, and tutu. Important habitat and corridor for a range of native birds. Approximately 202ha.



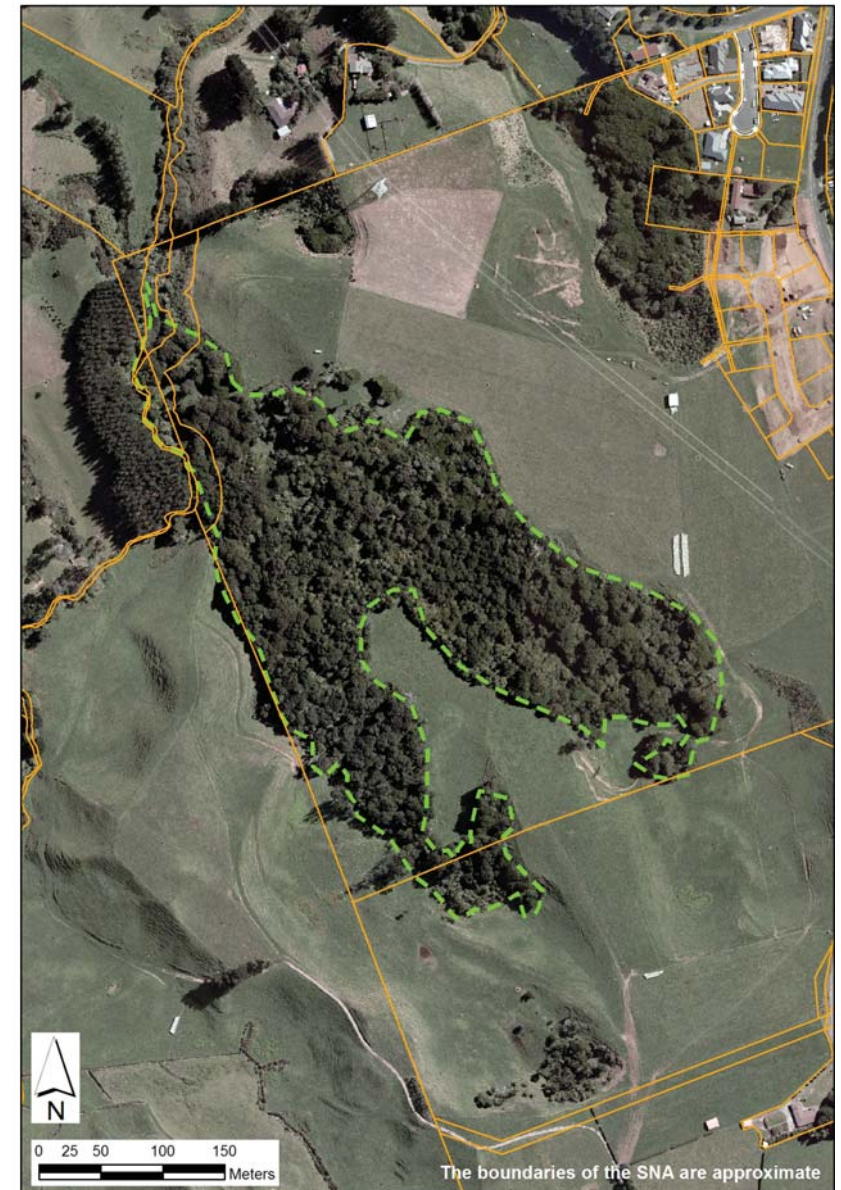

The canopy is dominated by tawa and pukatea with hinau, rewarewa, pigeonwood, kanono and occasional northern rata. Provides habitat for a range of indigenous forest birdlife. Underlying geology is Stratford Formation and Lepperton Lahars. Approximately 9.5ha.

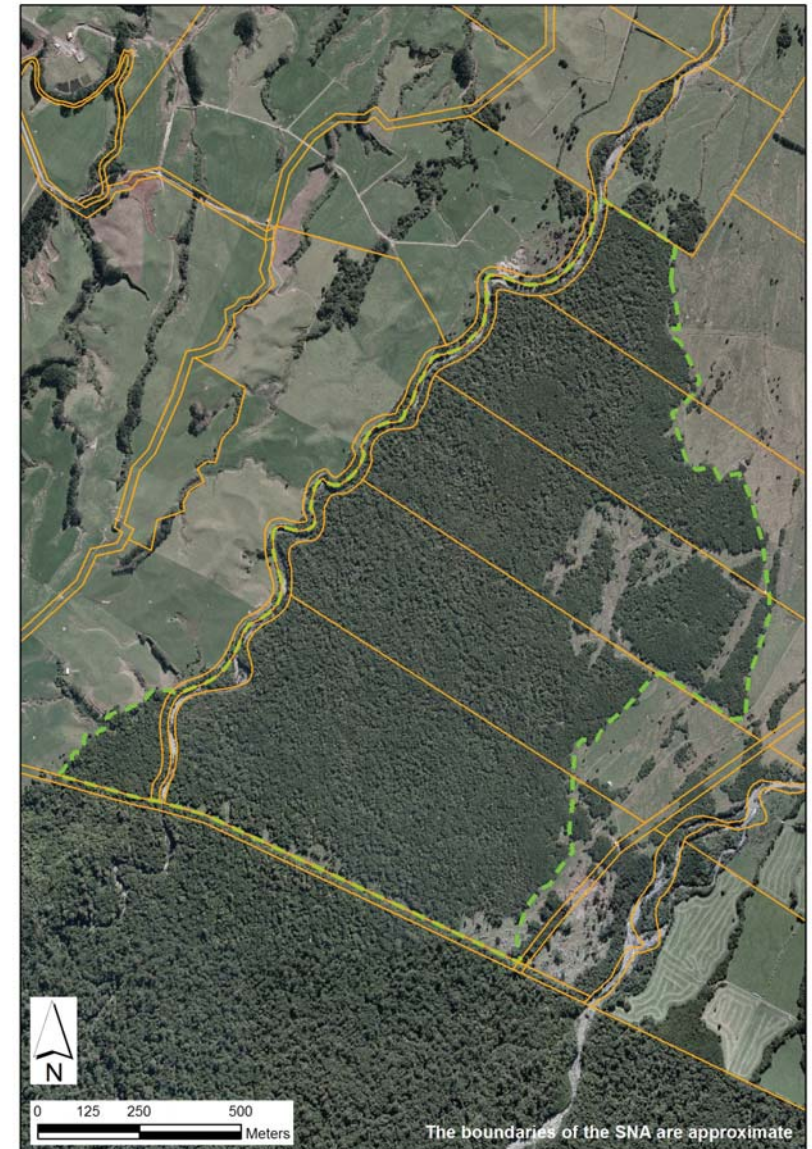

SNA Value: One of the largest and most natural remnants of lowland tawa forest on the ring plain. The forest lies on debris flow material alongside the Waitepuke Stream and minor tributary. Tawa dominates the canopy with occasional emergent rewarewa and rimu on the slopes, while pukatea increases in importance on the lower slope and in the gully. The site is well fenced and the diverse understorey is in good condition. The forest and riparian vegetation provide habitat for a range of indigenous birdlife. Approximately 6.5ha.

SNA Value: A large remnant of previously logged swamp forest on lahar debris flow material adjoining the National Park. Predominant canopy species include kamahi and swamp maire, with smaller stands of tawa and kahikatea. Scattered hinau and miro are also present along with occasional emergent rimu, northern rata and Hall's totara. The site is distinguished by swamp maire and swamp maire-kahikatea forest with associated understorey species that can tolerate wet conditions. The site is bounded by the Waiwhakaiho and Kaiiauai rivers and extends to altitudes below the lower limits of the National Park. The forest and riparian vegetation provide habitat for a range of indigenous birdlife. Approximately 160ha.

SNA Value: A poorly drained hollow and adjacent sideslope on uplifted marine terrace. The swamp forest is pukatea dominant with scattered kahikatea and ti kouka. Tawa-kohekohe-puriri forest with kamahi, pigeonwood, mahoe and rimu predominates on the sideslope. The understorey includes dense supplejack, kiekie, kanono and kawakawa. A small area of Coprosma tenuicaulis/Carex sedgeland exists on the previously cleared western margin. Provides habitat for a range of indigenous forest birdlife. Approximately 5ha.

Other species include kamahi, rimu, pigeonwood and mahoe with a dense understorey of supplejack, kanono, kawakawa and kiekie. Provides habitat for a range of indigenous forest birdlife. Approximately 9ha.

Sub-canopy includes treeferns, pigeonwood, kanono, pate and kiekie. A small remnant of a forest type that was once extensive on the Egmont Ring Plain. Provides habitat for a range of indigenous forest birdlife. Approximately 7ha.

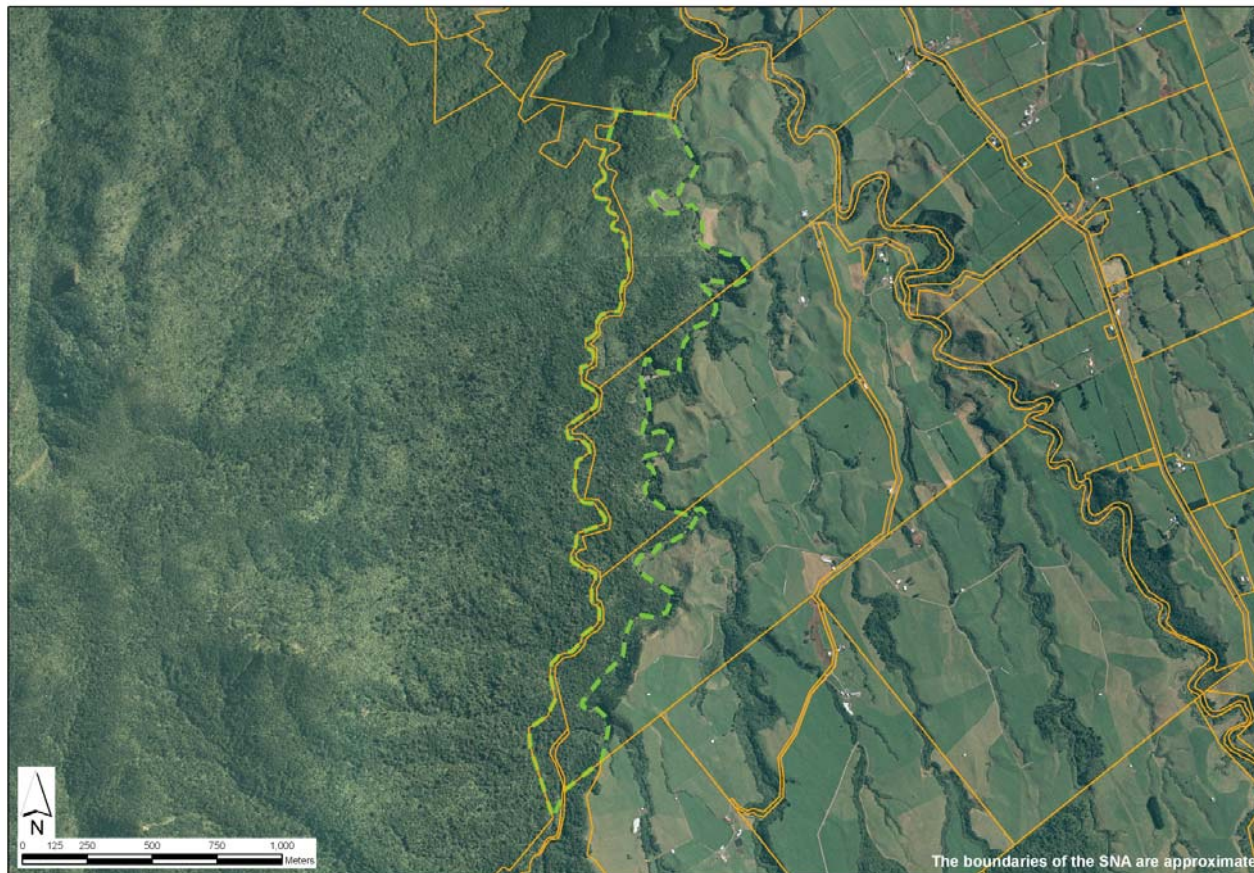

This area will regenerate to include species of lower altitude such as tawa flax providing a lower altitudinal variant of vegetation as well as important bird habitat. Approximately 100ha.

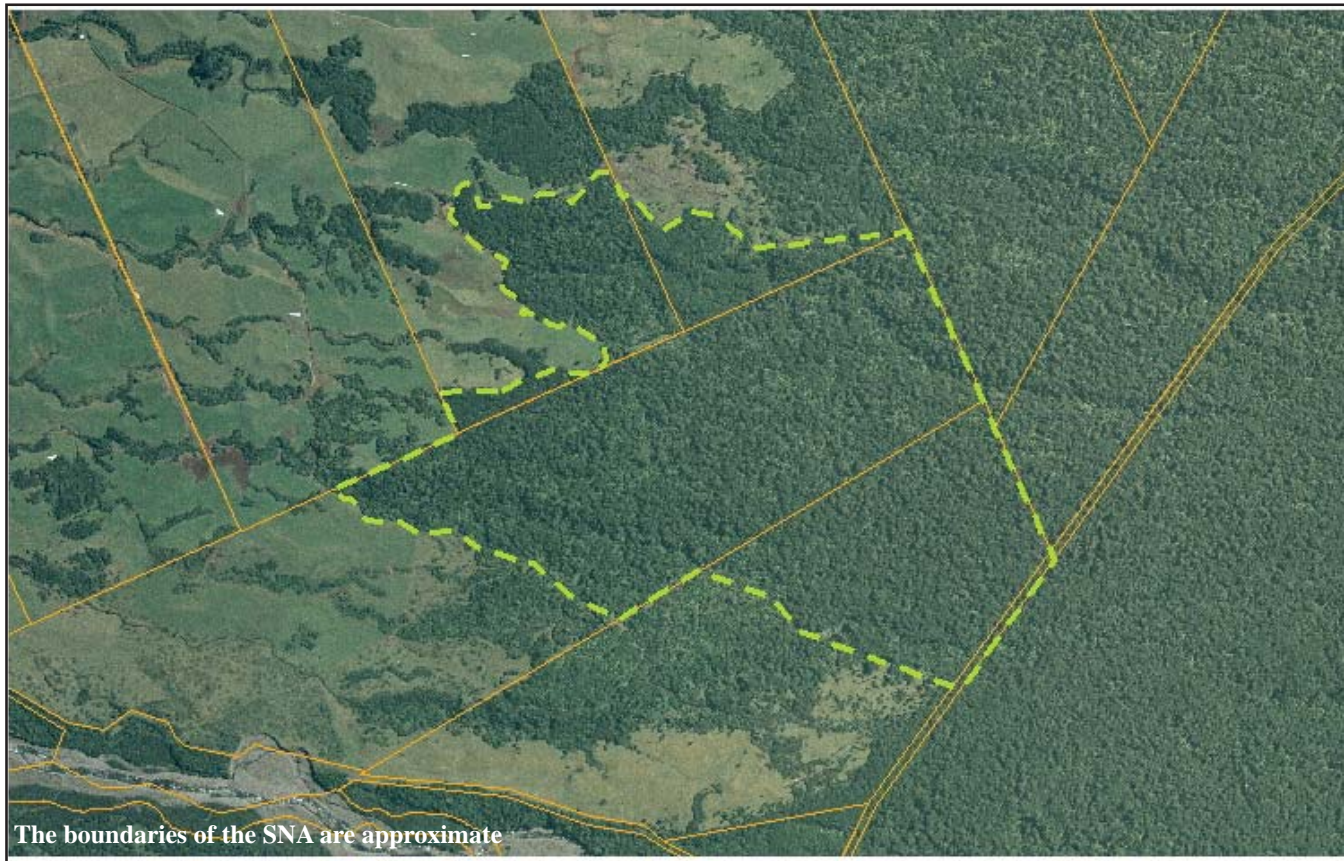
